

Monthly report for February 2018


Another month passes with few opportunities that were missed due to insufficient working capital allowing us to purchase them.

Prosper 2000 LLC created and evaluated nearly 140 deals out of which 41 were offered for partnerships. Only 12% of the pursuing properties were sold; the rest Redeemed.

Please note that not all deals are being offered / presented to investors.

Prosper 2000 LLC created and evaluated 116 deals out of which 19 were offered for partnerships. 16% of properties were sold. Remaining properties redeemed.

No surprise on seeing such a number of properties being redeemed. Even though majority of them Redeemed, we continue to focus on those that sold bellow the price we were willing to pay for.

There were three deals (below) in the month of February that sold below our Maximum Purchase Price out of which two were presented and offered for partnership.

A minimum 50,000 dollars profit was left on those three properties to other Investors that acquired them. As a reminder these are the profits, we are leaving for other investors to keep.

Note; Even though the min. profit is around 50K my profits estimate on those three properties is between 65,000 and 75,000.

We are tracking the progress of all properties other investors purchased and will report back to you with more accurate numbers on what the actual profits on those properties were. The rehab cost will always remain an estimate; however, my predictions and calculations are quite accurate.
